BOARD MEMBER RESPONSIBILITIES

- Serving as a trusted advisor to the ED as s/he develops and implements Micah's Place's strategic plan
- Reviewing agenda and supporting materials prior to board and committee meetings
- Approving Micah's Place's annual budget, audit reports, and material business decisions; being informed of, and meeting all fiduciary responsibilities
- Contributing to an annual performance evaluation of the ED
- Assisting the ED and board chair in identifying and recruiting other Board Members
- Partnering with the ED and other board members to ensure that board resolutions are carried out
- Serving on committees or task forces and taking on special assignments

- Ensure Micah's Place's commitment to a diverse board and staff that reflects the community Micah's Place serves
- Direct, and inspire the organization through the careful deliberation and establishment of policies, and development and implementation of a strategic plan
- Account to the general public for competent, conscientious, and effective accomplishment of its obligations as a body. It will allow no officer, individual, or committee of the Board to usurp this role or deter this discipline
